Conference Overview

The Nepal Entrepreneurship Forum is scheduled for June 2025 in Kathmandu, Nepal. This premier event will bring together thought leaders, entrepreneurs, policymakers, researchers, and experts from across the globe to discuss the theme “Towards Sustainable Entrepreneurship Ecosystem”. The conference aims to serve as a pivotal platform to explore sustainable business practices, foster innovative solutions, and connect the entrepreneurial community with the vision of creating a more resilient, inclusive, and sustainable economic environment.

This year’s forum will focus on the integration of sustainable principles into entrepreneurship, aligning with global efforts to achieve the Sustainable Development Goals (SDGs) and creating a positive impact for all stakeholders involved in the entrepreneurial ecosystem.

History

In 2016, King's College organized the "International Conference on Social Entrepreneurship" with the theme "Rebuilding Nepal through Social Entrepreneurship." Held in the aftermath of the devastating earthquake and political unrest, the event aimed to foster entrepreneurship and strengthen regional ties among academics and the entrepreneurial ecosystem. Endorsed by Nepal's Department of Industry and supported by Sherpa Adventure Gear, the conference brought together over 250 participants, including 30 international delegates. Featuring 4 plenary and 10 parallel sessions, 21 research papers were presented, and more than 20 entrepreneurial ventures were showcased. Key collaborators included Hyatt Regency, Teach for Nepal, and numerous I/NGOs.

Again, In 2017, King's College hosted the 16th International Entrepreneurship Forum in Kathmandu, themed "Sustainable Entrepreneurship and Economic Development." Organized with Essex Business School, University of Essex, the conference bridged gaps in sustainable entrepreneurship and economic development through conceptual, empirical, and practical insights. Endorsed by Nepal's Ministry of Education and partnered with global organizations like INSME and Yunus Social Business Center, the event featured 250 participants, including 80 international delegates, and 65 research paper presentations. Key sponsors included Nepal Rastra Bank, Radisson Hotel, and Khalti, with support from The Kathmandu Post and other prominent partners.

Yet again, In November 2018, King's College organized its third annual conference, "Entrepreneurship and Economic Growth in Federal Nepal," in Dhangadhi, Province 7. The conference aimed to assess Nepal's entrepreneurship agenda within the federal system, explore sustainable practices aligned with the UN's SDGs, and foster an entrepreneurial ecosystem for economic growth. Key themes included federal and local policies, social entrepreneurship, technology, innovation, and Vision 2030. Activities featured plenary and parallel sessions, networking, entrepreneurial venture showcases, and awards for outstanding research papers. The event welcomed representatives from government, academia, private sectors, and international institutions, with select papers published in the International Journal of Entrepreneurship and Economic Issues (IJEEL).

Background

The increasing global focus on organized dialogues and academic research has been encouraging. As a result, universities and governments worldwide are hosting conferences involving politicians, policymakers, researchers, financial institutions, and business startups to discuss advancements in entrepreneurship locally and globally.

In this global context, Nepal has become a key participant in these evidence-based discussions, with rising interest from government bodies, private sectors, banks, financial institutions, and startups over the past decade. To support these trends, King's College has been offering courses in entrepreneurship since 2012, now encompassing undergraduate and graduate programs in business, entrepreneurship, and information technology. The college also hosts an annual conference to disseminate its research findings to students, stakeholders, and the public, focusing on themes pertinent to entrepreneurship and Nepal's economic development. To continue this tradition King's College is organizing a second edition of a conference under the flagship of "Nepal Entrepreneurship Forum (NEF) with a theme "Towards Sustainable Entrepreneurship Ecosystem".

The conference theme highlights the necessity of fostering environments that support entrepreneurship while balancing economic growth with social and environmental sustainability. In our interconnected world, businesses are increasingly expected to innovate in ways that enhance societal well-being and environmental preservation, alongside achieving financial success.

A sustainable entrepreneurial ecosystem is more than a network of stakeholders such as entrepreneurs, investors, and policymakers; it integrates sustainability into business models to support economic, social, and environmental advancement. This ecosystem promotes innovations that align with the Sustainable Development Goals (SDGs) that ensure that business practices have a positive societal and environmental impact.

Key players such as governments, educational institutions, policymakers, researchers, and financial entities are crucial in shaping these ecosystems. They can drive sustainability by creating and incentivizing policies, providing funds for environmentally and socially impactful ventures, and developing educational programs focused on sustainable business practices.

In Nepal, the urgency of a sustainable entrepreneurial ecosystem is particularly pronounced due to the country's challenges in development and sustainability. Emphasizing sustainable entrepreneurship can address environmental degradation, social inequality, and economic resilience and help Nepal build a more inclusive and robust economy. The upcoming Nepal Entrepreneurship Forum II will serve as a platform for discussing these issues, bringing together diverse stakeholders to explore strategies for nurturing sustainable entrepreneurial ecosystems in Nepal and beyond.
